Every teacher you know has walked their room looking for blind spots. Every teacher you know has passed their classroom to see what it would look like from the outside.

Every teacher you know has wondered how fast they can lock a door. Every teacher you know has had a talk about the "spread out" or group together" methods.

Every teacher you know has gotten jumpy at least once at the sound of a fire alarm, unplanned announcement, or screech from the quad.

Every teacher you know has wondered if they could be in the way long enough to prevent damage.

Every teacher you know has thought about how hard it would be to keep young people quiet.

Every teacher you know has walked into a different classroom and noticed where the doors and windows are.

Every teacher you know.

As the aftermath of the most recent school shooting is unfolding, the Republicans are calling for prayer and the Democrats are calling for gun control. Across the country, many are heartbroken, angry, and ready for the social media battles over gun control which will get us absolutely nowhere. In a few days, it will be old news.

Below are statistics which actually matter in a moment like this. (The stats are from 2022 and 2023 and can be found via a simple Google search.)

- -- Iowa ranks 51st in the nation (yes, that's DEAD LAST) for access to inpatient mental health services.
- -- 21,000 students in Iowa who have been identified as having a "major depressive disorder" did NOT receive any treatment in 2022. None at all.
- -- Based on Iowa's population, we should have 416 inpatient mental health beds available just for our children in this state. We have 125.
- -- Iowa has 55 pediatric psychiatrists practicing IN THE ENTIRE STATE. Those practitioners serve 14 counties. Iowa has 99 counties and a child population of over 700,000.
- -- Roughly 20% of Iowa children have a RECOGNIZED mental health issue (which doesn't count those who don't bother to seek an actual diagnosis, because they know there's no help available). That's over 140,000 children in need of care.
 - -- Iowa has the 13th highest suicide rate among adolescents.
- -- In 2022, one organization serving children in mental health crises in an urban area of our state reported a waiting list of more than 550 children and pleaded for more resources to hire additional staff. They said many children had been waiting "over a year for CRISIS SUPPORT."
- -- The "big step forward" to address the crises-level of these numbers? Our legislators demanded the Suicide Prevention Hotline number be printed on the back of school IDs this year.
 - -- Additional funds for staff shortages? No.
- -- Additional support for community hospitals who have no resources for mental health programs? Nope.
- -- Incentives to encourage more mental health care providers to practice in rural Iowa communities? Not a chance.
- -- Removal of barriers to access insurance-covered online care across state lines? Not gonna happen.

If you don't think this is outrageous, you're NOT PAYING ATTEN-TION. We do not have a gun problem in Iowa. We have a mental health care crisis.

Brain health matters. And when you don't treat brain illness, it spreads. It infects people around the person suffering. And in some cases, it proves fatal. You can take away guns, but it won't fix anything. It won't save lives. It won't help our kids.

At times, we need our grandchildren more than they need us. They have no clue what they truly do for our souls.
